Service Agreement

This is a Service Agreement ("Agreement") between Dog Gone Walkers, LLC, a Wisconsin Limited Liability Company ("DGW") and _____ ("Client") for services rendered as set forth in the Services and Rates Section of this Agreement. Client's pet(s) are set forth in Client/Pet Information Sheet and shall be referred to herein as "Client's Pet" whether one or more. **updated 8/1/2019**

1. Client authorizes DGW to perform pet care services as set forth in the Services and Rates Section ("Services") of this Agreement.
2. DGW agrees to provide its Services in a timely, reliable, caring and trustworthy manner. In consideration for these Services, the Client waives and relinquishes any and all claims against DGW, provided reasonable care and precautions are followed. Client agrees to notify DGW of any complaints within 24 hours of Services being provided.
3. Client hereby authorizes DGW to obtain emergency veterinary care as necessary for Client's Pet and/or injuries caused by Client's Pet while Client's Pet is in the care of DGW. Client hereby acknowledges and accepts responsibility for any costs related to this emergency care and further agrees to reimburse DGW for same within Fifteen (15) days from date of care. Should Client's Pet be injured, DGW shall use the veterinarian indicated in the Client/Pet Information Sheet. Should this veterinarian not be available, Client authorizes DGW to seek an alternate veterinarian. Although DGW will make every effort to contact Client prior to obtaining emergency care, such contact is not a requirement of obtaining emergency care for Client's Pet or any injuries caused by Client's Pet.
4. Client shall provide proof to DGW that Client's Pet is current on all legally required vaccinations prior to DGW performing any Services.
5. DGW shall not be liable for any injury, disappearance, death or fines of Client's Pet with unsupervised access to the outdoors.
6. Client shall be liable for all medical expenses and damages resulting from Client's Pet injuring the pet sitter or other persons. Client agrees to disclose to DGW any Client's Pet history involving injury to any human or other animals or damage to property prior to DGW performing any Services.
7. DGW reserves the right to terminate this Agreement at any time, at its sole discretion; likewise, Client may terminate this Agreement at any time. However, Client shall be responsible for paying DGW for any Services performed up to the point of termination in either case.
8. DGW shall not be liable for any damages to the Client's property, or that of others, caused by the Client's Pet.
9. In the event DGW is required to employ a locksmith to gain entry to Client's premises due to a malfunction of the lock or key, Client shall be responsible for reimbursing DGW for all costs incurred by DGW. Client agrees to reimburse DGW for same within Fifteen (15) days from date of locksmith services.
10. Client acknowledges and authorizes this Agreement to be valid approval for future Services so as to permit DGW to accept telephone reservations and enter Client's premises without additional signed Agreements or written authorizations.
11. Client has read the terms and conditions of this Agreement and confirms the accuracy of the information provided. Client further acknowledges and approves the terms and conditions of this Agreement and agrees to said terms and conditions. Client's signature below indicates acknowledgement, approval and agreement.
12. Requests to cancel all scheduled boarding stays must be done at least 2 weeks prior to stay. Failure to do so will result in responsibility for full payment of services.
13. Client acknowledges and agrees to all amendments/changes of policy.
